Cost per Rider:

- \$375 for ECC Members, \$400 for DSDCTA Members and \$425 for Non-members – includes 2 days Instruction, stabling Friday night through Sunday afternoon (shavings not included, bring your own or may be ordered on Application), meals for rider, and educational sessions.
- \$200 Members, \$225 Non-members – 1 day Instruction, 3 meals, 1 night's stabling (two day participants have priority).

Day Auditors: \$15 Members per day, \$25 Non-members - includes lunch, educational sessions

Saturday Night Additional Meals - \$10 per meal

General information:

- There are limited riding slots available on a first come first served basis, however priority will be given to full camp participants (both days) over partial campers (1 day).
- Riders age 13 years and older are eligible to register for camp.
- There is no lodging available on site other than the RV slots and stalls for those willing to 'rough it' a little. There are bathrooms and showers available at the covered arena. Local hotel information will be made available. Most hotels are about 18 minutes from venue.
- Shavings are available for purchase for \$8 per bag. Please note number of bags needed below.
- One stall is included with Camp fee, but we have lots of additional stalls available at \$25 for the weekend. They can be used primitive camping, tack stall, Campers 2nd horse, auditor's, Karen Jones' students, non-participating horse, etc. Lots of stalls available, just ask! Please note number of *additional stalls* needed below.
- Dogs allowed on leash, but please be considerate in dealing with clean up, barkers and maintaining safe distance from horses.
- Helmets required while mounted. No Stallions.
